Ontex repurchases own shares through its liquidity contract

Aalst-Erembodegem (Belgium), June 10, 2019 – In the framework of the liquidity contract (see press release dated 10 December 2018), Ontex announces today that it has bought on Euronext Brussels **63,000** shares during the period between **June 03, 2019** and **June 07, 2019**.
