## **Ontex: Transparency Declaration Notification**

### **Disclosure made according to the requirements of Article 14 of the law of 2 May 2007**

Aalst-Erembodegem (Belgium), August 26, 2019 – Ontex Group NV (“Ontex”) discloses the notification of significant shareholdings that it has received according to the Belgian Law of 2 May 2007 on the disclosure of significant shareholdings in listed companies.

On August 21, 2019, ENA Investment Capital notified Ontex that it holds, as a result of the acquisition of voting securities or voting rights, 4,223,768 shares in Ontex and so has crossed the threshold of 5.00% of the total number of voting rights in Ontex to 5.13%.
